

## Terms of service

By using or visiting the FreeSpeechTube website or any FreeSpeechTube products, software, data feeds, and services provided to you on, from, or through the FreeSpeechTube website (collectively the "Service") you signify your agreement to these terms of service, and FreeSpeechTube's Privacy policy, found at <https://www.freespechtube.org/privacy/>. Although we may attempt to notify you when major changes are made to these Terms of service, you should periodically review the most up-to-date version.
